**Terms**

1. the Author grants the exclusive license to publish and sell the \_\_\_\_\_ Work in the Italian language in Open Access format, and paperback copies on demand, to the publisher Francesca Pagano, proprietor of Write Up Books© (hereinafer the Publisher);
2. the license shall have a duration of 5 (five) years starting from the date of this Agreement, and is meant to be renewed every year, unless a written communication will be perceived 90 days before the end of the term;
3. during the term of this Agreement, the Publisher will produce printed copies on demand; the Author licenses the Publisher the right to distribute the Work in ebook format (PDF, EPUB2) in Open Access;
4. the total amount of the cost of the publication is compliant to the Open Access policy of the Publisher, available at the link <https://www.writeupbooks.com/open-access-universita/>. The Author will receive 10 free copy;
5. the Author is, and will remain, responsible for any legal obligations relating to the use of third party identification signs in the Work;
6. the Author shall deliver the manuscript of the Work \_\_\_\_\_ by without prejudice to the fact that he may agree with the Publisher to postpone the delivery date of the requested material;
7. the Publisher reserves the right to postpone the effective date of publication of the Work, currently scheduled for \_\_\_\_\_ ;
8. on the the paper copies produced, both parties, in agreement with each other, will be able to make any changes that are deemed necessary; the same changes will be made to the version distributed in Open Access;
9. the Author undertakes to read and correct the proof of the Work prior to its publication;
10. the Author shall let the Publisher free to determine or modify the cover price;
11. the Publisher undertakes to communicate the release of the Work to the ISBN agency for the Italian language area for appropriate availability throughout the national territory;
12. the Publisher is responsible for sending the copies to the mandatory “legal deposit”, in accordance with the current Italian law;
13. starting from 1 year after the date of publication, the Publisher will furnish the Author with annual accounting of the sales;
14. the Author will receive the royalty of 10 (ten) percent of the retail price, on all net sales receipts for printed edition, starting from the 50th (fiftieth) copy sold. The Author will not receive any royalties on copies in PDF or EPUB2 format distributed in Open Access;
15. to the Author is reserved a 30% sale on the coverprice; he won't receive any royalties on the copies purchased by universities, libraries, foundations attributable to him;
16. the Author shall not receive any royalties on the copies purchased by himself;
17. the Author will not receive any royalties on free copies, or on damaged copies not available for selling;
18. the Author will receive 1 free copy of the Work;
19. if the Work is the winner of cash prizes in competitions or otherwise, the amount (less participation costs) will be divided 50 (seventy) percent/50 (thirty) percent between all the Editos (if more than one) and the Publisher;
20. the Parties authorize the processing of their personal data, according to the criteria established by Italian Decreto Legislativo n.196 del 30 giugno 2003 “Codice in materia di protezione dei dati personali”, for regular performance of this Agreement.
